Allan & Bath Premier Service & Guarantee is exclusively available to Allan & Bath landlords and enables us to provide you with the most comprehensive service that includes our guarantee in respect of unpaid rent and legal fees.

Although all Allan & Bath applicants are always thoroughly screened before a tenancy is agreed (we take great care to determine their suitability as a tenant and their ability to meet the requirements of the Tenancy Agreement) events may occur, especially during these times of financial uncertainty that alter their circumstances. For example, redundancy, divorce, ill health or bankruptcy.

Unforeseen events such as these may result in a tenant being unable to comply with the terms of the Tenancy Agreement:

- They may be unable to pay the rent
- They may fail to move out at the end of the tenancy
- There may be a delay in regaining possession of your home
- Disputes may arise between you and your tenant
- You may require alternative accommodation while possession of your property is being sought

## What are the Premier Service & Guarantee Limits?

The maximum compensation Allan & Bath will pay in respect of any Premier Service tenancy is £10,000.

Compensation payments equivalent to the full rent due will be made until vacant possession of the property is obtained. Additional payments equivalent to 75% of the monthly rent will also be made for up to 2 months following vacant possession being secured until the property is re-let, provided that Allan & Bath is instructed exclusively in this respect.

Alternative accommodation costs incurred directly by you are limited to an amount equal to 3 months rent. Certain other limits apply; please ask to see the full terms and conditions.

## Main Conditions

A tenancy deposit in accordance with the terms of the Tenancy Agreement must be collected from the tenant before the tenancy starts and be held by Allan & Bath who may use this to offset payment made under the guarantee.

Any compensation due to the landlord under this guarantee will be less a sum equivalent to two weeks rent due under the Tenancy Agreement. In the event that you wish to claim compensation under this guarantee relating to legal action in respect of a dilapidation claim you must notify Allan & Bath in writing within 14 days of the claim arising. The minimum amount in dispute must exceed the deposit held by £500.

Once vacant possession has been obtained the property must be made available for reletting exclusively with Allan & Bath and you must accept any reasonable offer of tenancy in excess of 85% of the monthly rent for the preceding tenancy.

Certain other conditions apply; please ask to see the full terms and conditions.

## Typical Example of Benefits

Assume you have a 6 month tenancy with a rental income of £650 per month. In the third month your tenant loses his job and stops paying the rent. It could take you approximately 4 months to obtain possession of the property (including a possession warrant), and possibly a further month before your property is re-let.

With Allan & Bath Premier Service & Guarantee you will be paid compensation of £3,087.50 (four months of rent until possession is gained plus 75% of one month's rent until the property is re-let) less the equivalent of two weeks rent (£300). You will also be paid the full legal costs (approximately £700) for obtaining a possession order and judgement for the arrears. Any additional legal costs approved by Allan & Bath - which might include an application for a possession warrant or subsequent recovery action - will also be covered by Allan & Bath Premier Service & Guarantee.

In this example, which represents a typical tenant default, you would receive a total of £3,487.50 for a monthly cost of £17.88 plus VAT. Compensation payments are advanced extremely quickly by industry standards. Without Allan & Bath Premier Service & Guarantee you could lose a total of £3,850 in lost rent and court costs. You will be dealt with personally by our in-house staff who will be happy to help with the necessary paperwork and ensure that any arrears of rental income are paid to you promptly - generally within 30 days of becoming due, which is unusually quick by industry standards.
